3. Benefits Achieved:

The implementation of TPM allowed the plant to achieve both tangible and intangible benefits. All the outcomes are measured by PQCDSME parameters. After the introduction of TPM, the process & procedures are streamlined and systematic. The people become more proactive, and a sense of ownership has been successfully instilled, that contributed to their effectiveness.

Prominent Tangible benefits achieved at business level.

- 1) Manufacturing output has increased, which helped to achieve the growth of business volume from 54000 tons/annum to 70000tons /annum.
- 2) The On time in full delivery performance has improved from 65% to 90%.
- 3) Manufacturing conversion cost reduced 5% from Benchmark year.
- 4) Asset turnover increased by 2 times.
- 5) There are Zero major accidents since implementation of TPM.
